

RULES OF PROCEDURE FOR BOCHER AND CLOSY WASTEWATER N°000621/2018

Article 1 : Role of Waste Departments :

The warehouses at Closy in Chamonix and Bocher in Les Houches have the role of:

. To allow inhabitants, municipal services, shopkeepers and craftsmen of the communes of Chamonix, Les Houches and Vallorcine, to evacuate waste not collected by the household waste service, under good conditions,

. To limit the multiplication of wild deposits,

. Valorize most materials (recycling material, composting green waste, energy recovery by incineration) and to treat as best as possible certain specific categories of materials (Hazardous household waste).

. Decrease volumes of products to be incinerated

Article 2 : Opening hours :

Waste-disposal facilities will be made inaccessible to the public outside opening hours.

Only waste from the territory of the community of communes is accepted. Custodians may request the address of the work for verification.

Article 3 : Waste accepted :

The following household waste is accepted:

/!\ Mixed wastes are billed as bulky

Article 4 : Prohibited waste :

Are forbidden :

Garbage,
Industrial waste,
Putrescible waste (with the exception of green waste)
Hazardous waste of artisans and traders.
asbestos

Article 5 : Restriction of access to the waste dump :

Access to the waste collection center is restricted to passenger vehicles and any vehicle with a vehicle width of less than or equal to 2.25 meters

and a GVWR of less than 3.5 tonnes.

The authorized professional users must have direct access to the green waste storage platform after weighing on the weighbridge of the installation and visual inspection of the loading by the custodian.

Article 6: Parking of users' vehicles:

The parking of vehicles belonging to the waste collection center is authorized only for the dumping of waste in the containers.
The users will have to leave this platform as soon as the unloading is finished in order to avoid any congestion on the site of the waste collection center.

Article 7 : Behavior of users :

Access to the waste collection center, and in particular waste dumping operations in containers, automotive maneuvers, is carried out at the risks and perils of the users.

Users must :

- respect the rules of circulation on the site (stop at the entrance, speed limitation, sense of rotation ...)
- respect the instructions of the guards
- not to descend or to be recovered in tippers and containers
- do not climb on guard rails

Article 8 : Separation of materials :

Users are requested to separate the materials listed in Article 3 and to place them in the containers or containers provided for this purpose.

Article 9 : Quantities accepted - Establishment of the fee :

The quantities accepted:

individuals depositing more than 10 m3 in the year will be considered professionals beyond the annual 10m3

Le Closy :

They will be strictly limited to 2 m3 per day at the Closy for users. Professionals are directed to the Bocher waste collection center.

Volumes greater than 2m3 will be refused at Closy and directed on Bocher

Bocher :

Accessible to professionals for: cartons, glass, wood, bulky, incinerable, metal
the daily allowances are billed to the professionals to the volume, or to the weight taken from the first unit. In case of dispute on the volumes, the waste will be weighed and the tariff applied to the tonne applied. They are free for individuals.
Green waste from private individuals taken by professionals is considered as professional waste

Special case : inert :

Inert waste: - Individuals can take 10 m3 of waste per year beyond that they are considered professional producers and sent to a treatment center.

Inactive professionals are no longer accepted in Bocher

Refusal of inert in small quantity (individuals, professionals are evacuated with the bulky and invoiced to the pro

Article 10: Guarding and receiving of users :

The custodian shall be present at all times during the opening hours provided for in Article 2 and shall be responsible for:

- ensure the opening and closing of the waste collection center,
- ensure the maintenance of the site,
- inform users and obtain a good selection of materials,
- keep records of entries, exits and claims, to manage the evacuations of materials.

Article 11: Infringement of Regulation

Any delivery of prohibited waste as defined in Article 4, any wiping action or, in general, any action aimed at hampering the proper functioning of the waste dump, is liable to a report drawn up by a municipal employee in accordance with the provisions of the Code of Procedure.

The custodians may refuse access to the rubbish dump: in the case of breach of these regulations, not settlement of the royalties due
